SECTION 4: First aid measures

Description of first aid measures

First-aid measures general

: In case of spontaneous vomiting, transport the victim to a hospital, to verify the possibility that the product has been aspired into the lungs.

First-aid measures after inhalation

: In case of disturbances owing to inhalation of vapours or mists, remove the victim from exposure; keep at rest; if necessary, seek medical attention. See also Point

First-aid measures after skin contact

: Take off contaminated clothing and shoes. Wash thoroughly with soap and water. If inflammation or irritation persists, seek medical advice. In case of contact with hot product, cool affected part with plenty of cold water, and cover with gauze or clean cloth. Call a doctor or bring to an hospital. : Rinse eyes thoroughly for at least 15 minutes. Keep eyelids well apart. If irritation persists, seek medical advice. Do not use salves or ointments, unless directed by doctor.

First-aid measures after ingestion

Do not induce vomiting to avoid aspiration into the lungs. If the person is conscious, rinse mouth with water without swallowing. Keep at rest. Call for medical assistance or bring to an hospital. If the casualty is inconscious, place in the recovery position. In case of spontaneous vomiting, keep head low, to avoid the risk of aspiration into the lungs. Do not give anything by mouth to an unconscious person.

Most important symptoms and effects, both acute and delayed

Symptoms / injuries (general indications) : Prolonged and repeated skin contact may cause reddening, irritation and dermatitis.

Symptoms/injuries after inhalation

This product has a low vapour pressure, and in normal conditions at ambient temperature the concentration in the air is negligible. A significant concentration may build up only if the product is used at high temperature, or in case of sprays and mists. In these cases overexposure to vapours may cause irritation to airways, nausea and dizziness.

Symptoms/injuries after skin contact

: Prolonged and repeated skin contact may cause reddening, irritation and dermatitis. Contact with hot product may cause thermal burns.

Symptoms/injuries after eye contact

: Contact with eyes may cause a light transient irritation. Contact with hot product or vapours may cause burns.

Symptoms/injuries after ingestion

Accidental ingestion of small quantities of the product may cause irritation, nausea and gastric disturbances. Taking into account the taste of the product, however, ingestion of dangerous quantites is very unlikely.

Indication of any immediate medical attention and special treatment needed

SECTION 5: Firefighting measures

Extinguishing media

Suitable extinguishing media

5.3. Advice for firefighters

Protective equipment
